 - 6.1. SC1: Measurement and Instrumentation SC1 Chair (Griffin)

6.2. SC2: Definitions – SC2 Chair (Channas) The Scope, Duties and Membership were shown. The new SC8 Chair (David Schaefer) was added to the roster. Randy Long

The <u>motion carried</u>. The draft PINS for C63.36.TPC was shown. ISED and FCC were encouraged by this effort since no test method is available. <u>Bob moved</u> to accept the TPC PINS. Discussion ensued. Nick brought up using this Standard number for C63 history. (under C63.36). Dan H. noted that each of our Standards already have their history in the front matter. Consensus was to use the numbering for this standard. The motion carried. The TPC PINS will be provided to Jennifer at the IEEE.

6.8. SC8: Medical Equipment Testing – SC8 Chair (D. Schaefer) David Schaefer (the new Chair) showed the modified Scope, Duties and roster. David moved to approve the Membership, modified Scope and Duties of SC8. No comments, no discussion, no opposition, no abstentions. The motion carried. Meeting highlights were shown.
