- 5.1. Review list of C63[®] documents, PINS and PINSC
- C63.2 is presently withdrawn. It will probably be republished within the next two months. Low priority for analysis.
- C63.4 There was a failed ballot. There will be a new balloting group and ballot. Low priority for analysis.
- C63.5 There is no international counterpart to this document. The date should be corrected to 2006.
- C63.6 Is withdrawn.
- C63.7 There is no international counterpart to this document. [Comment from Werner Schaefer after the meeting: there is some content in CISPR 16-1-4.] PC63.7D This is a leftover document.
- C63.011-2000 Reprint of CISPR 11. This document needs to be withdrawn.
- C63.8 Is withdrawn.
- C63.9 This document has tougher limits than 61000-4-3. This document has international counterparts.
- C63.10 There is no international counterpart to this document.
- C63.11 There is no international counterpart to this document.
- C63.12-1999 There is no international counterpart to this document.
- C63.13-1991 Withdrawn. CISPR 17 is an international counterpart. Low priority for analysis.
- C63.14-1998 Dictionary, should be published by year end. The international counterpart is IEV 161. Dr. Showers indicated that there are some international terms that SC2 may be interested in including in the list of definitions. Since the document is being published this year, the revision will be in five years. Therefore work can begin now, no leader selected.
- C63.15 Should be published in six months. There are international counterparts in the 61000 series.

C63.16-1993 - ESD. There is material on reliability that is not in the international standard. SC77B is the active international committee. **AI 2** *Ed Hare to contact Bill Rhoades to see if he would take the lead on this input.* Richard Worley volunteered to work on this.

C63.17-1998 - It was revised in 2006. There is no international counterpart to this document.

C63.17 D3.5 - Revised in 2006

C63.18-1997 - Reaffirmed at a later date. **AI 3** *Ask Joe Morrissey if he would be willing to accept the lead on this analysis.*

Instead of using the complete Head of Delegation (HoD) report for SC3, only item 2f of the HoDs will be captured to report the impact of the meeting to US issues. The following is excerpted from item 2f of the 2007 Sydney HoD Reports:

- CIS A Yes. The items are antenna calibration project, test site validation in the frequency range 1 GHz to 18 GHz, evaluation of set-up table in the frequency range above 1 GHz, and use of spectrum analyzers for compliance measurements.
- CIS B [There is no HoD report for 2007]
- CIS D Yes. The CIS A and D JTF's for Chamber Validation and FFT measurements did have meetings to begin these JTF efforts.
- CIS H Yes, the issue of antenna height scanning above 1 GHz will require coordination with CIS I and CIS A. The issues associated with CIS_H_151_CD and CIS_H_161_CDV will require coordination and a JTF with CIS A. The issue of limits > 1 GHz for floor standing equipment will require coordination with CIS B and CIS A. The issues of inappropriate drafting of documents by CIS H for measurement procedures should be referred to the SMB and to the IEC Central Office for final determinations of publication of the document. Although these items were noted in section 2f, the comments do not address US issues.
- CIS I No. There are no issues.

It was noted that not all of the comments in 2f identify "issues" for the US. Chairman Andersen suggested that there should be a CISPR teleconference after the annual CISPR meeting to review the HoD reports. It was also suggested that such a teleconference should be held before the 2008 meetings so that it is understood in advance what information is needed in item 2f for coordination.
