#### C63.15- Recommendation on action: Heirman

Heirman provided update on current status of standard. Meeting occurred past Monday. Named task leaders during meeting and currently soliciting expertise support for references including MIL-STD 461. Planning webinar at the nd of August to discuss soliciting support status and other items such as reverb chambers. Efforts are to clean up 2010 revision of C63.15 with draft expected by early 2016. No action by SC3 until after publication of new revision C63.15.

#### C63.16- Discuss after publication: Whitesell

Whitesell provided status update. C63.16 ready to be put into ballot. Not expected to be published by Fall 2015 C63 meeting. Status unchanged.

#### C63.19- Report on industry discussion: Berger

Hoolihan provided update with Berger absence and commented document is currently stable with no activity at this time. Item to remain open for input from Mr. Berger.

[Subsequent to the SC3 meeting, Steve Berger indicated that there exists satisfactory communication between the C63 development activity and the Chair of the International Committee. He does not anticipate that there is a need for SC3 involvement to foster communication of US concepts on the subject. Until there is a defined need, the item will be removed from the agenda.]

#### 8. Old Business and discussions

8.1 Issues from IEC (including CISPR), ISO and other international standards activity potentially affecting US standards development: Chair

Don Heirman noted hot topics including wireless power transfer, interference from LED lighting, measurement limits for smart grid technology 9 kHz – 150 kHz. PINS to be presented this week on some of these topics in C63 Main Committee meeting.

#### 8.2 Report from WG1 on C63.12: Andersen

Standard recently balloted. Ballot group included 16 members. There were no negative votes, one no return, 4 abstentions, 11 positive votes with 5 positives with comments all of which have been successfully reviewed. Many accepted or accepted with modification, and 2 items that were not incorporated due to unclear comments. Needs to be re-circulated with clean copy and redline copy by Pat Roder to the balloting group for informational purpose. Next step is IEEE editor review.

#### 8.3 Smart Grid Proposals

Don Heirman noted Smart City proposals related to Smart Grid. US has Smart Grid interoperability panel that includes EMI working group working on a test plan for implementing IEEE STD 1613.1. Potential application of C63.15 and C63.9. Lots of Smart Grid activity nationally and internationally. To remain on agenda and Don Heirman to provide a report during next SC3 meeting.
