Scope: Revision of IEEE Std C63.17-1998. Specific test procedures are established for verifying the compliance of unlicensed personal communications services (UPCS) devices with applicable regulatory requirements regarding radio-frequency (RF) emission levels and spectrum access procedures.

Status: Current. No plans for further maintenance at this time.

Purchase: <u>IEEE Store</u>. To purchase individual standards, go to the IEEE store and search on the standard number.

A working group will be formed to address the comments from the reaffirmation review.

Some comments were received. It wasn't clear whether they were technical or editorial. There will probably be only a few changes to address the comments and then the standard will be on its way.

Dave Case reported that it was discussed whether to move C63.17 to SC4. It was decided to leave it in SC7 because it's mostly coexistence.

C63.27-draft: American National Standard for Evaluation of Wireless Coexistence

Contact: Berger, Stephen (Working Group Chair)

Scope: This revision of the C63.27 standard provides improvements to the evaluation procedure and supporting test

methods for wireless coexistence and evaluation of key performance indicators (KPI). The revised standard will provide evaluation procedures, test methods and other guidance necessary for performing the evaluation.

Status: Current. New revision being developed.

Purchase: Current version available for sale

Jason noted there has been a fair amount of work, the most recent was on April 22nd, 2021. More people are becoming interested. Highlights from the last meeting, in January, in was moved to SC7 for review. In was voted to move to SC7 for review. A new member from R and S was introduced. He has been added.

Did an overview of outreach efforts. Coexistence is a relatively new topic. Jason did a webinar last week for Washington labs. About 90 people attended. There are more efforts underway.

Motions include a motion to move C63.27 to SC7 for initial review.

Upcoming paper in EMC Magazine - Omar et al.

Jason asked if there was interest for Edition 3. Dave Schaefer proposed something about testing for 13.56 MHz. Something about interest based on requests from FDA.

Jason got a request to do on-site coexistence training.

The WG continues to gather feedback on C63.27 and its use.

The revised standard is ready for submission to the subcommittee. Also to SC2 and SC3 for their review.

The WG is trying to build a more user-friendly standard.
